The fee is \$500/1 week, \$900/2 weeks, and \$1200/3 weeks. For each additional child from the same family, there is a discount of 10%. Any additional single day would cost \$60. There is no tax to be paid by you! The parent/guardian is responsible for the transportation of a child to the camp and back home. A minimum deposit of 100 CAD must accompany each application. In the case of cancellation prior to June 15, a cancellation fee of \$20/child is deducted. The balance must be paid before June 15. After June 15, no refund will be possible. If you are a member of the Hostyn Association (annual fee is \$20), there is a discount of \$25 for the first child. Anybody can become a member. NOTICE TO PARENTS OR LEGAL GUARDIANS

We are striving for excellence. Camp Hostyn is not a specialized camp for youth with mental health issues, behavioral issues, or special needs. For this reason, Camp Hostyn reserves the right to refuse or sent home any camper without any monetary compensation that we feel we cannot safely accommodate or integrate into the camp program.

The following are not tolerated at our camp and will result in the immediate expulsion of a camper from Camp Hostyn: violence, bullying and intimidation, hate speech, theft, running away, possession of weapons, drugs, alcohol, or tobacco, electronic cigarettes, and repeated rule breaking. Basically, any act that puts campers, staff, or others at risk of physical, emotional, or psychological harm will result in a camper being sent home immediately. The child must be picked up the same day the parent or guardian is contacted unless other arrangements have been agreed upon at the time.

For the health and safety of all camper and staff, any camper who is sick (fever, diarrheas, vomiting, etc.) will be sent home immediately to prevent the spread of illness. Furthermore, any camper who sustains an injury that limits or prevents their participation in camp activities for an extended period will also be sent home. Camp Hostyn doesn't have extra staff to tend to injured or sick youth, nor do we have additional facilities for housing injured or sick youth.

It is important to recognize that camp is not for everyone. Campers will be sent home if they are constantly unwilling to actively participate in camp activities if they regularly ask to go home or if they frequently complain. It is our goal to ensure the campers have a positive experience at our camp. Forcing a camper to be there against their will does not make the experience a positive one for them and often affects the entire group in a negative manner, ruining everyone's week.

It is the parent's or legal guardian's responsibility to arrange timely transportation to pick up their child at Camp Hostyn or a nearby hospital if they are being sent home for any reason. Again, a reminder that the child must be picked up on the same day you are contacted. Our camp will contact Youth Protection and/or the Police if a parent refuses or is unable to pick up their child without a valid reason.

Every parent knows if her/his children possess or use a cell phone. Therefore, it is the parent's responsibility to verify that their children do not have in their bags any cell phones, computers, electronic games, and similar electronic devices.

IMPORTANT: Any camper found with banned items such as electronics, weapons, alcohol, drugs, tobacco, or electronic cigarette will be sent home immediately without any exception. **Please, discuss the above rules with your child before arriving at our camp**.
